With reference to the Fee Circular No. 1400(47)/Head-AA/Fee Structure/2011 dated 19.05.2025 shared by Head-AA, NIFT HO. Students of NIFT Delhi are hereby informed the following:

The students are required to pay the applicable fee with ref to the attached Circular as per the schedule mentioned below and to note the NIFT rules on non-payment and re-registration:

- Last date of depositing the fee for July-December, 2025 is 18<sup>th</sup> September, 2025. Fee with a late fine of Rs.100/- per day can be deposited till 3<sup>rd</sup> October, 2025.
- 2. Last date of depositing the fees for the session January to June, 2026 is **16<sup>th</sup> February**, **2026**. Fee with a late fine of Rs. 100/- per day can be deposited till **02<sup>nd</sup> March**, **2026**.
- **3.** PG students of 3<sup>rd</sup> Semester will be required to pay the Alumni Association Membership Fee (One time) (Non-Refundable) of Rs. 5,900/-.
- 4. Students rejoining to repeat the semester and those rejoining after availing Leave of Absence (LOA) are required to contact their concerned CCs before the commencement of the session to complete the formalities. Students on leave of Absence (LOA) will be required to pay the re-registration fee of Rs. 10,000/ + 18% GST (Rs. 1,800/) = Total Rs. 11,800/per absenting semester. Repeat students will be required to pay the re-registration fee of Rs. 10,000/ + 18% GST (Rs. 1,800/) = Total Rs. 11,800/ as well as non-refundable annual charges towards Library and Student Development & Medi-claim and Exam Fee over and above-mentioned amount.
- **5.** The name of the student will be struck from the rolls of the institute without any further notice in case of non-payment of fee after the specified date.
